#### Would you like to help with a new project in Surrey tackling invasive species along the River Wey?

Many of you will already be aware that we are facing a serious problem from invasive species. The picture shows a particularly fine display of Himalayan Balsam which has now got a real grip on local riverbanks and adjoining areas along the River Wey. Guildford and Waverley Friends of the Earth has been concerned about this for some years but tackling it is a large project requiring money, people and resources. Fortunately Surrey Wildlife Trust (SWT) has taken the issue up and has been appointed by DEFRA to head the Wey Valley catchment project. SWT is drawing together a list of volunteers who would like to survey for invasive species and also help with practical sessions removing Himalayan Balsam from the River Wey Catchment. We are certainly hoping an HB 'pulling session' can be organised in the Guildford and Godalming sections of the Wey this summer and we know there is already considerable local interest in this. **Selborne Brickworks** – new application submitted for planning permission for Anaerobic Digester to take food waste

As many of you know, in the summer of GWFoE supported a planning application for a new AD plant at Selborne in Hampshire, which is not far from Guildford and the towns of Waverley which are now collecting household food waste. There is currently no AD plant for municipal food waste operational in Surrey. Surrey's municipal food waste collections alone are expected to produce 150,000 tons of food waste and although Surrey County Council has plans for a 40,000 ton AD plant in the north of the County at Shepperton there is clearly a need for more AD plants in this part of the South East as this 150,000 ton figure excludes commercial food waste.

A new planning application has been submitted to Hampshire County Council (HCC) for the proposed AD plant at Selborne. This has the all the benefits of the last application but on a smaller site thus removing the major planning policy objection which caused it to fail last time. The AD plant will take mainly food waste (20,000 tones) with some cattle slurry (2,500 tons) and will use the biogas created to fuel the brickworks. The heat from the brickwork kilns can then be used to warm the AD feedstock – a great example of synergy! Hilary has already written to HCC with our support and others may also wish to do so. The HCC application number is

There is a second application in the pipeline as some of the new access is within the South Downs National Park. This is already constructed but requires a change of use. However we don't have the application number or a website link for this yet but that should follow in the next newsletter.
