Food Waste update

Great news for Selborne Brickworks:-

We were delighted to hear that Selborne Brickworks planning application for a 20,000 ton Anaerobic Digester 8 miles south west of Farnham, to process food waste and slurry on part of the brickworks site, finally got planning consent from Hampshire County Council on 23 May. We like this proposal for a number of reasons - there is an onsite use for the biogas which will be used to fire the kilns in the adjoining brickworks which are currently lying idle because of the huge hike in the price of fossil fuels in the last few years. The surplus heat from the brickworks will be used to heat up the digester's feedstock. There is also a local farmer who wants to take all the digestate. However we think it has taken far too long to get to this stage for a scheme with such obvious benefits! It has required numerous planning applications and appeals over a number of years and for the last 18 months GWFoE's own planning expert Kathy Smyth has been providing an important supporting role.

And an interesting proposal for AD at Dunsfold Aerodrome:-

News just in is that BioGroup has lodged a planning application with SCC for a 25,000 ton AD facility to take commercial food waste. BioGroup has developed a number of AD facilities elsewhere in the country and perhaps the best known is the AD facility in Suffolk which takes the waste from the Adnam's brewery. Nationally Friends of the Earth supports anaerobic digestion as the preferred means of dealing with food waste and locally we certainly want Surrey County Council to maintain its antiincineration policy so it is important that GWFoE supports alternative schemes like this, if they are generally acceptable. We believe Surrey generates about 150,000 tons of mainly household food waste and a very large but unknown quantity of commercial food waste. We understand that initially the BioGroup facility will focus primarily on commercial food waste - probably diverting food waste currently being land-filled at Redhill. Dunsfold Aerodrome has both gas and electricity grid connections and seems the most suitable place in the southern part of

the county to establish these facilities. For these and other reasons we are already giving this scheme very serious consideration and discussing the application directly with BioGroup.
