Blackwater Valley and GWW Friends of the Earth groups have both objected to the planning application for the 3,600 unit Aldershot Urban Extension (AUE) made by Grainger plc. This was a huge application so GWW FoE concentrated on the renewable energy and sustainable build aspects. Our analysis revealed that the

detailed application for the 228 residential units in Phase 1 does not comply with Rushmoor's own policy in certain important respects. For instance, the policy for the AUE adopted by Rushmoor Borough Council in 2009 stated "The Council will expect all housing in the first phase of development to achieve a level of performance rating equivalent to BREEAM 'Very Good' or Code Level 4, with at least 10% of units achieving a level of performance equivalent to BREEAM 'Excellent', or Code Level 5 (100% improvement on 2006 Building Regulations) as per the Code for Sustainable Homes. This will need to be supported by a commitment to achieve certification under an appropriate scheme at the detailed design stage." In fact Grainger has offered Code Level 4 for only 22 houses (10%) out of the first 228 and the rest are to be Code Level 3 (which is now regarded as equivalent to the recently improved building regulations). - So not the "exemplary development" in terms of climate change and sustainability which Grainger promised Rushmoor Council! Let's hope that the Council insists on compliance with its own policy.

The film Chasing Ice was shown successfully on April 10th in Woking Borough Council Chamber to an enthralled 40+ audience. GEF showed it in Guildford last week and I hope they found it as stunning photographically as we did. Catch if you can- it has a powerful message too!

Surrey County Council has published a draft Rail Strategy report for consultation. It can be viewed online at www.surreycc.gov.uk/surreyrailstrategy. Reinstatement of the Guildford-Cranleigh railway line, which we as a group support, was considered by the consultants appointed by Surrey but has been rejected "because of the lack of a viable business case". The report says that "Previous detailed feasibility studies into the scheme carried out for Surrey County Council have concluded that patronage would be insufficient to justify the significant cost of line re-opening. There is no evidence to suggest that the fundamental drivers of demand have changed substantially since these studies were carried out in the 1990s."

This is very different conclusion from the findings of the Association of Train Operating Companies in 2009 which put a re-opened Guildford to Cranleigh line as a good commercial prospect. We think that re-opening this line would also help to alleviate some of the serious traffic problems experienced in the centre of Guildford by reducing the volume of traffic approaching Guildford along the A281. GWWFoE will be considering this consultation at a future meeting of the local group.
