Trees, bees & badgers - & other challenges for 2013.

have identified a number of risks posed to bees by three neonicotinoid insecticides, Friends of the Earth's Executive Director Andy Atkins said: "The clear link between neonicotinoid pesticides and declining bee health must sting the Government into action - we can't afford to dither when it comes to protecting these key pollinators."

From a different aspect, "Blinded by Science" by Matthew Silverstone was published in 2011. His hypothesis is that bees have faced a cocktail of pesticides for a long time. Bees and birds know where they are going using the Earth's magnetic field, which is about 10Hz. Silverstone's theory is that mobile phone masts use electromagnetic fields down to 10 Hz and this is what is disorientating bees. The timing is right - 2000 is roughly the year when CCD and mobile phones started. More research is needed here as well as it could be another important factor into bees decline.

You may be aware of the much publicised SCC and Action Surrey switching scheme www.surreyswitchandsave.org "Surrey's Hassle free energy switching scheme to save £££ on your bill". We at GW FoE are concerned that it is extremely unlikely to involve a green tariff. We are all in favour of saving money, but if you are a supporter of 'Clean British Energy' (i.e. renewable energy) we think you should know that you won't be furthering that cause or encouraging people to conserve energy. We are at present trying to push for a green tariff to be included in this scheme –but the problem apparently is that the organisers will only offer a tariff that is fixed-price for a reasonable period and the bigger green energy suppliers won't commit to this.

More positively, Action Surrey has succeeded in their bid for money from DECC to cover two things:

1. subsidised or free Green Deal Assessments for Surrey residents
2. additional marketing effort on Green Deal - basically an extension of DECC's scheme from Sept - http://www.decc.gov.uk/en/content/cms/news/pn12_107/pn12_107.aspx)

Planning and Development

There will be more about the emerging planning policy for both Guildford and Waverley in the next newsletter but in the meantime one specific development in Waverley is causing some concern

This is an outline planning application for 100+ houses on the redundant land at **Milford Hospital**. Although the site is quite close to Godalming as the crow flies, the access into Godalming is up a backroad which has a single track section. However the main concern we have about this site is that the Homes and Communities Agency, which is the applicant, has including misleading information about access to bus services in the application and generally glossed over the transport and access difficulties.
